(1) Fish Processing Regulation

- In 2014, responsibility for provincial Fish Inspection was transferred from MNR to OMAFRA.
- Ontario Regulation 456-Quality Control under the Fish Inspection Act. Under this regulation OMAFRA provides oversight of fish processors that distribute within the Province.
- OMAFRA monitors food safety in processing plants regulated under the Fish Inspection Act.
- Some processors may also be inspected by Public Health Units under the Health Protection and Promotion Act.

Proposed Changes

- Proposal: To replace the Provincial Fish Inspection Act with a new regulation under the Food Safety and Quality Act, 2001.
- This would enhance food safety while minimizing burden to the industry by:
- Preventing contamination rather than responding to its occurrence
- Focusing on higher risk processing rather than processing that is low-risk
- Eliminating duplication in government inspection
- Allowing for flexibility in how processors achieve food safety outcomes

Status of Proposal

Potentially Regulated

Higher-risk processing

- Smoked fish
- Canning
- Ready-to-eat products (RTE)
- Vacuum or modified atmosphere packaging
- Licensed meat plants that process fish

If distributing any of these products to other businesses (e.g., restaurants, stores)

...would require a licence

Potentially Out of Scope

Businesses processing food products containing 25% or less of fish by weight, **except if RTE**

Lower-risk processing (e.g., cutting, filleting)

Any fish processing if all products sold <u>directly</u> to consumers

(2) Bill 156

- Security from Trespass and Protecting Food Safety Act 2019
- Creation of Animal Protection Zones and prohibits people from entering into these Zones without prior consent of farm owner/occupier. Prohibits people from interfering with a motor vehicle transporting farm animals
- Fine (max of \$15,000 for first offence to \$25,000)
- Gives the owner/occupier of the farm the ability to arrest a person who is trespassing with use of force

Restitution for Damages

- If a person is found guilty the court may make a restitution order for any injury, loss or damages
- Limited liability clause-protects the owner/occupier from damages including injury, loss or damage suffered to the trespasser unless the owner created a danger with a deliberate attempt to do harm
- Time limitation of two years after the day the offence was committed

(3) Crown Land Sale for Agriculture

- MNRF has recently released a new policy on Crown land sale for agriculture.
- The goal is to support the growth of the Province's agri-food industry to diversify the Northern Ontario economy.
- The policy will assist proponents interested in traditional crop/livestock projects where Crown land may be required.
- The applicant leads the process with an application
- The ministry takes into account a variety of factors
