

FOOD SOVEREIGNTY:Food contributes to school success

Did you know that Canada is one of the few industrialized countries without a national food program? The federal government needs to invest in our children and the best way they have to do this is by ensuring that our children have access to healthy school food. With the rate of diabetes and obesity at an all time high, particularly amongst Indigenous peoples, it is of critical importance that children get access to healthy food at school. The Chiefs of Ontario and Nishnawbi Aski Nation have endorsed calls for a universal Healthy School Food Program as developed by Food Secure Canada.

Food Secure Canada is an alliance of organizations and individuals working together to advance food security and food sovereignty, and is a founding member and organizational host for the Coalition for Healthy School Food. The Coalition is a network of over 160 organizations from across Canada, advocating for a cost-shared universal healthy school food program that would enable all students in Canada to have access to healthy meals at school every day.

According to Food Secure Canada, one third of students in elementary school, and two-thirds of students in secondary school do not eat a nutritious breakfast. School food programs contributes to scholastic success and have the potential to create jobs. When local food is served, more jobs are created, impacting local economies.

In 2019, the federal government committed to working toward a national school food program.

Resetting the Table; A People's Food Policy for Canada is a national food policy report developed by a network of over 3500 Canadian organizations and individuals. It is based on ten detailed policy discussion papers that were generated through extensive consultation with Canadian citizens. The People's Food policy is rooted in the concept of food sovereignty.

The school food program being developed by Canada will be in alignment with 17 Sustainable Development goals shared by other UN countries.

In 2019, Canada launched the Food Policy for Canada. The vision for this policy is that all people are able to access a sufficient amount of safe, nutritious and culturally diverse food.

The Food Policy for Canada will be led by a Food Policy Advisory Council. The Local Food Infrastructure Fund is one initiative launched under this policy, which will support community-led projects to improve access to safe and healthy foods. The program includes grants to help prevent hunger by investing in infrastructure needs. The application period for this program has currently been extended to September 3 2021.

CANADA COMMUNITY REVITALIZATION FUND The Canada Community Revitalization Fund (CCRF) aims to help communities across Canada build and improve community infrastructure projects so they can rebound from the effect of the COVID-19 pandemic. With a national investment of \$500 million over two years, the Fund's purpose is to support not-for-profit organizations, municipalities and other community groups, as well as Indigenous communities:

- build new community infrastructure and revitalize existing assets
- bring people back to public spaces safely as health measures ease
- create jobs and stimulate local economies

Under the fund, FEDnor can supply up to 100% of the funding for projects with Indigenous groups. https://www.ic.gc.ca/eic/site/icgc.nsf/eng/07732.html

AGRICULTURAL CLIMATE SOLUTIONS FUND is a \$185 million, 10-year program that will help develop and implement farming practices to tackle climate change. Through agricultural practices such as shelterbelts or cover crops, farmland can trap and store carbon and reduce greenhouse gases.

ACS is a program under the more than \$4 billion Natural Climate Solutions Fund. AAFC is partnering with Natural Resources Canada (NRCan) and Environment and Climate Change Canada (ECCC) to develop projects that invest in natural climate solutions, including NRCan's Growing Canada's Forests program and ECCC's Nature Smart Climate Solutions Fund.

JOBS AND GROWTH FUND The Jobs and Growth Fund provides funding to businesses and organizations to help create jobs and position local economies for long-term growth. Eligible applicants include businesses,co-operatives, not for profit organizations and community

RURAL ECONOMIC DEVELOPMENT PROGRAM The program has two project categories:

- The Strategic Economic Infrastructure stream provides up to 30 per cent in cost-shared funding for minor capital projects that advance economic development and investment opportunities.
- The Economic Diversification and Competitiveness stream provides up to 50 per cent in costshared funding for projects that remove barriers to business and job growth, attract investment, attract or retain a skilled workforce, strengthen sector and regional partnerships and diversify regional economies.

FIRST NATIONS AGRICULTURE FOR SEVEN GENERATIONS PROGRAM-TEACHING OPPORTUNITY AT IAPO

IAPO (Indian Agricultural Program of Ontario) is a First Nation not-for-profit corporation, established in 1984. IAPO endeavours to empower First Nation communities through financial support and training for farmers.

In 2020, The First Nations Agriculture for Seven Generations Program was created in partnership with IAPO and AgScape to support increased First Nation participation in the farming and Agriculture Sector. The goal of the project is to engage First Nation Youth's interest in farming and agri-business possibilities and opportunities. First Nations Communities have always played an integral role in the history of farming and agriculture which has shaped the industry around the world. Through the lessons developed by this partnership- the students will learn about the Past, Present, and Future impacts of participating in farming and agriculture locally and globally.

To help assist in the delivery of the program, IAPO is seeking applications from qualified individuals for the position of Seven Generations Lead.

Position: Seven Generations Lead

Working under the supervision of the Program and Communications Coordinator, you will be responsible for delivering lessons and presentations on agriculture and food related topics as part of the First Nation Agriculture for Seven Generations Program.

This is a Part-time Contract position for delivery of class lessons throughout school year.

Responsibilities

IAPO will work with the Seven Generations Lead to deliver virtual Ontario curriculum-linked lessons to First Nations secondary school students in north eastern and south western Ontario, with the goal of returning to in-class delivery once the challenges of the pandemic subside. The Seven Generations Lead will have a variety of opportunities to participate in agriculture education events. Seven Generations Lead will also work with IAPO staff to develop a local network of schools and events in which to deliver lessons and presentations using IAPO materials.



NATIONAL DAY FOR TRUTH AND RECONCILIATION SEPTEMBER 30th

September 30th has been created to give everyone an opportunity to recognize and commemorate the legacy of Indian Residential Schools, which more than 150,000 First Nations, Metis and Inuit children were forced to attend between the 1870s and 1997.

The day is one of the 94 recommendations in the Truth and Reconciliation Commission's final report. The day itself was officially created on June 3, 2021, when Bill C-5 was passed by both houses of Parliament.

Since 2013, Sept. 30 has been observed as Orange Shirt Day across the country - a day, created by residential school survivor Phyllis (Jack) Webstad, on which Canadians wear orange shirts to commemorate the Indigenous children who were taken from their homes and placed in residential schools

The colour orange is significant because it was the colour of Webstad's shirt on her first day of residential school - a shirt that was taken away from her once she arrived.

Anishinabek Nation Food Map

The Anishinabek Nation, Lands and Resources Department is developing an Agricultural Asset Inventory, database and online food map of existing agriculture and food related businesses owned by Anishinabek Nation individuals. The map includes restaurants, farms and agricultural businesses and community initiatives such as farmer's markets, community gardens, and other initiatives.

The purpose of the online food map is to serve as a marketing tool which could result in business attraction and expansion, and identification of potential markets. One objective is to identify opportunities for increased purchase of local goods resulting in enhancement of local economies. In addition, it will also enable First Nation community businesses to grow and network with other businesses in other regions of Ontario. The data can be used as a benchmark to monitor agricultural development in the 39 Anishinabek Nation communities.


